The disaster recovery allowance (DRA) is for employees and sole traders who lose income because of a major disaster. You can get payments for up to 13 weeks after the disaster happens. These payments are taxable. The Australian Government is providing this allowance for 46 Victorian LGAs. More areas may be added depending on how they are affected by flooding. 	Australian Government Disaster Recovery Payment (AGDRP)	Australian Government	 The Australian Government Disaster Recovery Payment is for people who have suffered a significant loss because of the floods. This includes if your home was severely damaged or destroyed, or if you suffered a serious injury. If you are eligible, adults can get \$1,000 and children can get \$400. This payment is currently available residents in 14 impacted Victorian LGAs. More areas may be added depending on how they are affected by flooding. Equivalent financial assistance will also be available to eligible New Zealand citizens ('non-protected' Special Category Visas, subclass 444 holders) affected by the floods.
