# **NEW DOGS/CATS**

To register a dog or cat three months of age or older, please visit one of our Customer Service Centres or contact Customer Service on 5366 7100.

# **REGISTRATION TAG**

Registration tags must be worn on dog/cat collar at all times. Where a registered dog/cat is found outside the owner's premises not wearing the registration tag, the owner may be found guilty of an offence and upon conviction, be liable to a penalty of not more than two penalty units. As lifetime tags were issued in 2008, registration renewals will not receive a new tag. If you have lost your animal tag or can no longer read it, please contact Council for a replacement.

## LOST, FOUND AND ANIMAL ADOPTIONS

Moorabool Shire Council's domestic animal pound is located in Bacchus Marsh. It provides a safe haven for lost, abandoned and surrendered animals within our Shire.
