### Reduced Fees

- A dog or cat which is desexed
- A dog or cat over 10 years of age
- A dog or cat kept for breeding at a registered Domestic Animal Business
- A dog or cat registered with an applicable organization and their owner is also a member of that applicable organization
- A dog kept for working stock
- A dog which has undergone obedience training with an approved organization

To qualify for the reduced fee, you must provide documentary proof or complete a statutory declaration.

### STATE GOVERNMENT LEVY

A State Government Levy is applied to all animal registrations and is primarily used to fund responsible pet ownership education programs. This fee is incorporated within your registration payment.

## IMPORTANT INFORMATION

### NEW DOGS/CATS

To register a dog or cat three months of age or older, please visit one of our Customer Service Centres or contact Customer Service on 5366 7100. From 11 April 2013 all new animal registrations with Moorabool Shire Council, unless both microchipped and desexed, will not be eligible for a reduced registration fee.

### REGISTRATION TAG

Registration tags must be worn on dog/cat collar at all times. Where a registered dog/cat is found outside the owner's premises not wearing the current marker, the owner may be found guilty of an offence and upon conviction, be liable to a penalty of not more than one penalty unit. As lifetime tags were issued in 2008, registration renewals will not receive a new tag.

### LOST, FOUND AND ANIMAL ADOPTIONS

Moorabool Shire Council's domestic animal pound is located at 50 Osborne Street, Maddingley. It provides a safe haven for lost, abandoned and surrendered animals within our Shire as well as a very successful animal adoption program.
